RECOGNITION ORDER

WHEREAS in terms of section 14(1) of the NCTE Act, 1993, Shri Guru Nanak Shiksha Samiti, Village/Town-Fazalpur Mehrola, Tehsil/Taluka-Kichha, P.O-Rudrapur, Town/City-Rudrapur, Distt.-Udham Singh Nagar-263153, State- Uttarakhand has submitted an application (Code No. NRCAPP-30) to the Northern Regional Committee of NCTE for grant of recognition for conducting B.Ed. Course with an annual intake of 100 (One Hundred only) dated on 15.10.2009 in the name of Shri Guru Nanak Degree College, Village/Town-Fazalpur Mehrola, Tehsil/Taluka-Kichha, P.O-Rudrapur, Town/City- Rudrapur, Distt.-Udham Singh Nagar-263153, State-Uttarakhand.

2. AND WHEREAS on scrutiny/perusal of veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography the Northern Regional Committee in its 204th meeting held on 27th to 29th August, 2012 is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Shri Guru Nanak Degree College, Village/Town-Fazalpur Mehrola, Tehsil/Taluka-Kichha, P.O-Rudrapur, Town/City- Rudrapur, Distt.-Udham Singh Nagar-263153, State-Uttarakhand for conduction B.Ed. Course of Secondary level of one year duration with an annual intake of 100 (one hundred) from the academic session 2012-13 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfillment of the following conditions:-

- I. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- III. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
